1. Army Contracting Command - Rock Island (ACC-RI) has a requirement for Army Cloud Computing Enterprise Transformation (ACCENT). The ACCENT requirements are to provide commercial cloud solutions for eligible Army enterprise applications. The Army is moving designated Information Technology applications, systems, and associated data to the commercial cloud. ACCENT will be used to allow Army application and mission owners to obtain cloud transition support services and commercial cloud hosting services in any combination. The ACCENT Basic Ordering Agreement (BOA) will be the Army's preferred source used by all Army commands and organizations requiring commercial cloud services.

2. BOA W52P1J-18-G-0016 is executed with Strategic Communications, LLC, subsequently referenced as "BOA Holder". The established period of performance (POP) is 27 February 2018 through 26 February 2020 with an annual review.

a. Any additional terms and conditions that may have been provided with the proposal submission will not be considered. BOA holders may consider submitting these terms and conditions at the task order level for consideration.

b. The BOA as well as current DOD PA Certification can be found on the CHES website at <https://chess.army.mil/> for agency use in ordering purposes.

3. The estimated cumulative contract maximum for all Task Orders for all BOAs will be \$247,700,000.00.

4. The execution of a BOA does not guarantee that the Government will place future contracts or orders with the BOA holder. There is no guaranteed minimum for BOA holders.

5. BOA holders are required to maintain the capabilities as proposed under the BOA. SECTION H - SPECIAL CONTRACT REQUIREMENTS

1. TASK ORDER COMPETITIONS:

As requirements for cloud hosting services arise, a Task Order request (TOR) will be competed among the qualified BOA holders in accordance with the procedures listed here and in the TOR. Each BOA will designate the conditions under which they are eligible to propose based upon the DoD-PA certificates held for each BOA holder and the impact level approved for each certificate holder. Any changes or additional DoD-PA certification acquired must be submitted to the BOA Contracting Officer for approval. Each TOR will define the specific services to be acquired and any other requirements for the services being procured.

a. The cognizant Ordering Contracting Officer (OCO) will issue a TOR to the BOA holders upon identification of the need for an order. The USG's TOR does NOT constitute an authorization to start work nor serve as a basis for any future claims against the USG.

i. Task Orders (TOs) may utilize the following contract types: Fixed Price (FP), Firm Fixed Price (FFP), labor-hour, or Time and Material.

ii. TOs may be evaluated utilizing the following procedures: Best Value Tradeoff, Low Price Technically Acceptable (LPTA), or Price only. Evaluation criteria that may be used at the TO level are: Technical, Management, Organizational Capability, Past Performance, Small Business Participation, Price and any subfactors under each of the factors as determined by the TOR Contracting Officer.

iii. TOs shall contain a Small Business Participation evaluation factor for all contractors holding a BOA (with the ability to propose for the stated requirements); Small Business Subcontracting plan is required by other than small business concerns only (Separate documents). Small Business set-asides must comply with the Limitation on Subcontracting clause.

iv. The TOR OCO reserves the right to apply the "rule of 2" for one or more task order requirements to limit to Small Businesses (SB), when/if the TOR OCO determines two or more responsible SB BOA Holders are capable of executing the requirements of the TOs. In this case, the TOs will be competed to SB BOA holders only.

v. It is the USG's intent to issue TORs that reflect a Performance-Based contracting approach IAW FAR Part 2.101.

vi. Deliverables may be defined and required at the TO level. When deliverables are required, the TO will include a Contract Data Requirements List which will identify the format and delivery schedules for any required deliverables.

vii. Government Furnished Property, Equipment, and/or Materials will be specified at the TO level.

viii. All USG owned data delivered as part of the capability migration will remain USG owned throughout the performance of the TO. The data developed as a result of operating or maintaining the application over the TO Period of Performance (POP) shall be considered USG owned data. All USG owned data shall transition to the USG specified destination upon request by the USG.

ix. TOs may be issued for a maximum period of performance (POP) of five years, to include all options. TORs will include 52.217-5 Evaluation of Options if options are considered. Orders become binding upon acceptance of the order.

x. TOs may utilize commercial contracting procedures. The TOR OCO should consider the following commercial clauses for inclusion if the requirements are determined commercial:

- FAR 52.212-1 Instruction to Offerors -- Commercial Items
- FAR 52.212-2 Evaluation -- Commercial Items
- FAR 52.212-3 Offeror Representations and Certifications -- Commercial Items
- FAR 52.212-4 Contract Terms and Conditions -- Commercial Items
- FAR 52.212-5 Contract Terms and Conditions Required to Implement Statutes or Executive Orders -- Commercial Items
- DFARS 212.301(f) list commercial DFARS clauses

2. Travel:

Offeror travel required for performance of TOs awarded under the BOA shall be performed in compliance with DoD Joint Travel Regulations (JTR). The USG will approve all Contactor travel prior to trip initiation. No local travel will be authorized as part of this BOA or TOs awarded under this BOA.

b. An annual meeting with all BOA holders may be necessary to review BOA terms and conditions, discuss potential upcoming requirements, any potential changes to the BOAs, and any other issues deemed pertinent. In addition to annual review requirements, there may be event-driven circumstances requiring BOA or Service Level Agreements (SLA), that are defined at the TO, for review. An example of an event-driven review would include newly published overarching Cloud Guidance/Policy which may impact the Army cloud requirements.

When unable to take advantage of the benefits, the Contractor shall promptly notify the Contracting Officer and give the reasons. The Contractor shall give credit to the Government for cash and trade discounts, rebates, scrap, commissions, and other amounts that have accrued to the benefit

On the basis of the most accurate information available to the Contractor, the notice shall state --

- (1) The date, nature, and circumstances of the conduct regarded as a change;
- (2) The name, function, and activity of each Government individual and Contractor official or employee involved in or knowledgeable about such conduct;
- (3) The identification of any documents and the substance of any oral communication involved in such conduct;
- (4) In the instance of alleged acceleration of scheduled performance or delivery, the basis upon which it arose;
- (5) The particular elements of contract performance for which the Contractor may seek an equitable adjustment under this clause, including --
 - (i) What line items have been or may be affected by the alleged change;
 - (ii) What labor or materials or both have been or may be added, deleted, or wasted by the alleged change;
 - (iii) To the extent practicable, what delay and disruption in the manner and sequence of performance and effect on continued performance have been or may be caused by the alleged change;
 - (iv) What adjustments to contract price, delivery schedule, and other provisions affected by the alleged change are estimated; and
- (6) The Contractor's estimate of the time by which the Government must respond to the Contractor's notice to minimize cost, delay or disruption of performance.

(c) Continued performance. Following submission of the notice required by paragraph (b) of this clause, the Contractor shall diligently continue performance of this contract to the maximum extent possible in accordance with its terms and conditions as construed by the Contractor, unless the notice reports a direction of the Contracting Officer or a communication from a SAR of the Contracting Officer, in either of which events the Contractor shall continue performance; provided, however, that if the Contractor regards the direction or communication as a change as described in paragraph (b) of this clause, notice shall be given in the manner provided. All directions, communications, interpretations, orders and similar actions of the SAR shall be reduced to writing promptly and copies furnished to the Contractor and to the Contracting Officer. The Contracting Officer shall promptly countermand any action which exceeds the authority of the SAR.
